

## Schedule for Upcoming Meetings Progress and Preliminary Draft Plan Review Phases

The following is an initial schedule for the Children's Hospital and Regional Medical Centers Master Plan Citizens Advisory Committee (CAC) review of the preliminary drafts of the Children's Hospital and Regional Medical Center's Master Plan (MIMP) and supporting Environmental Impact Statement (EIS). Note that this portion of the process deals with the CAC's initial comments to: 1) a very preliminary progress report on a Preliminary Draft Plan and Preliminary Draft EIS; and 2) a Preliminary Draft Plan and Preliminary Draft EIS that is provided to the CAC. Both the preparation and review of these latter two documents is unique to the City of Seattle's Major Institutions Program and is intended to give the CAC an opportunity to make very early comments and give very early guidance to the development of the initial plans and supporting documents that will later be formally reviewed as the Draft Master Plan and Draft EIS.

This phase of the process will be followed by Children's Hospital and Regional Medical Center (CHRMC) revisions and or changes to the preliminary Drafts and their publication of formal Draft Documents for Full CAC and Community Review.
